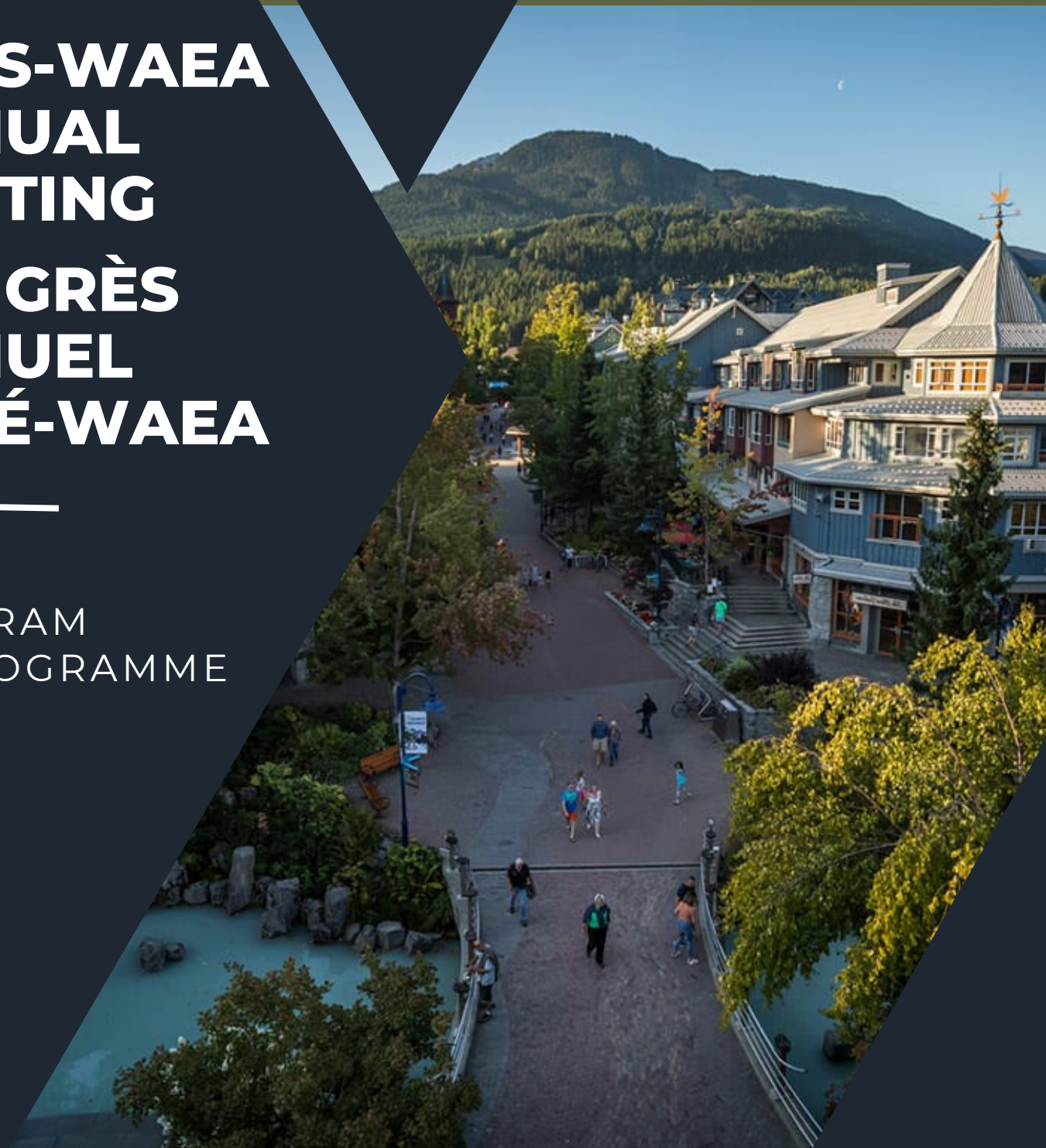

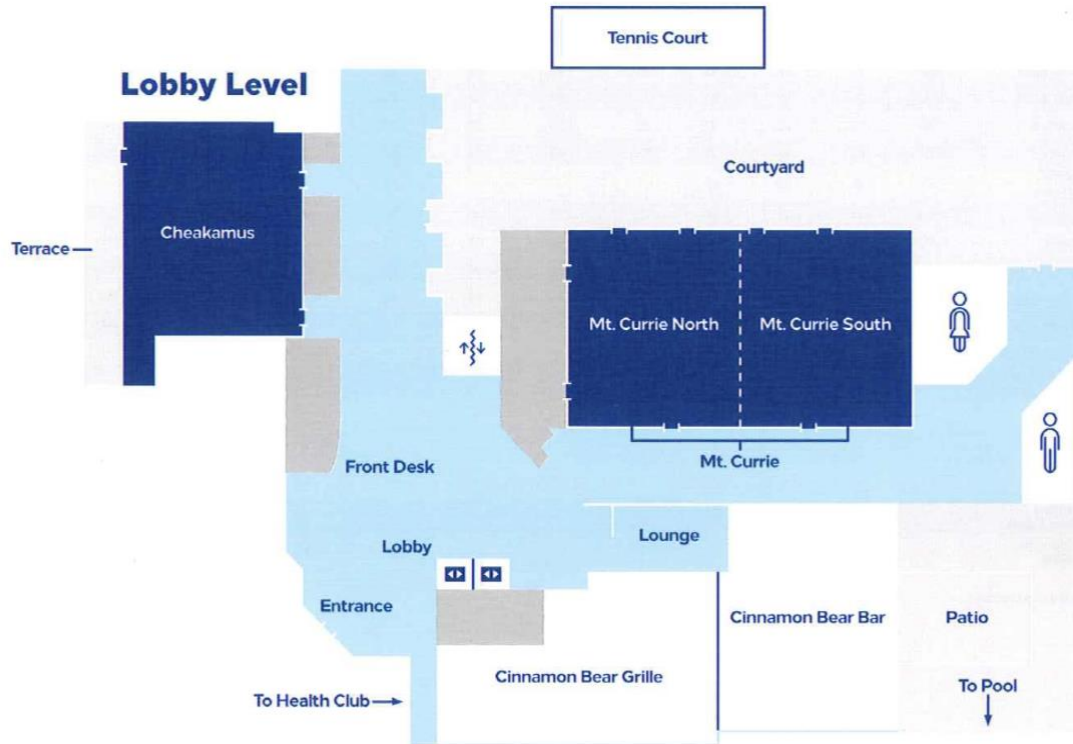

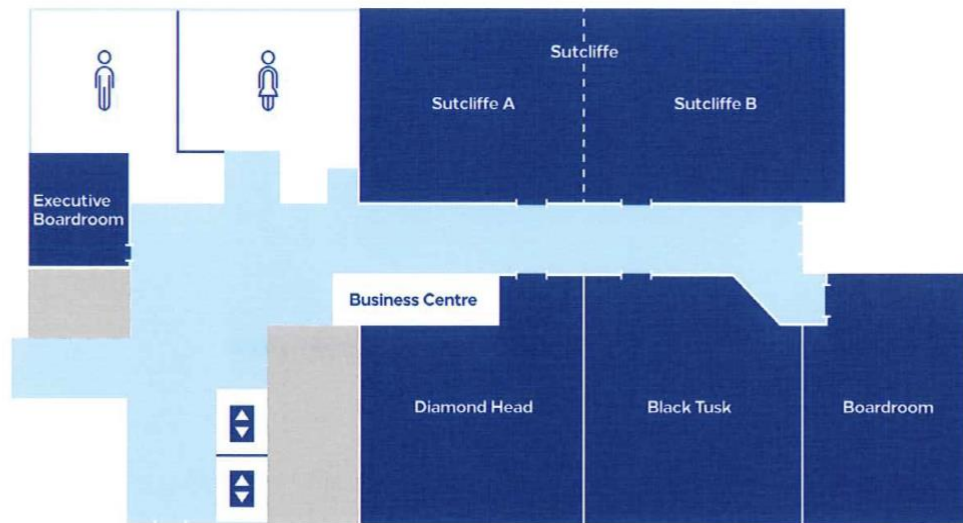
HOTEL FLOOR PLANS | PLAN D'HÔTEL

Environmental Metrics: From Theory to Practice

The Challenge of Carbon Taxation: Economic Theory Meets Partisan Politics **Kathryn Harrison, University of British Columbia**

Carbon taxes offer a cost-effective way to reduce carbon pollution. However, governments that propose carbon taxes invariably face political opposition from both carbon-intensive industries, farmers and small businesses, and voters at large. In some cases, such as Canada in 2008, carbon taxes have been rejected. In others, including Australia and Alberta, carbon taxes have been adopted but repealed. In still others, including France, carbon taxes have been frozen in response to public protests. Yet in other jurisdictions, among them Sweden, Ireland and Canada, carbon taxes have survived and are steadily being increased. This presentation will draw on comparative case studies to better understand the conditions under which carbon taxes can be adopted, survive and increased to the levels necessary to attain significant emissions reductions – and under what circumstances should give up on carbon taxes and employ more politically-favourable policy instruments instead.

**3:30 PM - 4:15 PM: Presidential Address: Implications of Increasing
Automation in Primary Agriculture**
Tristan Skolrud, University of Saskatchewan

In developed countries, farming occupies a smaller share of labour than it ever has. Technology, automation, and genetic advancements have contributed to this phenomenon; an innovation process hundreds of years in the making. And while most sectors of the economy are preoccupied with the plight of labour in line for replacement by automation, I argue in this presidential address that the larger concern for agriculture is the capital-intensified industry that's left behind—what happens to agriculture without farmers? I discuss possible influences of automation on land tenure, the adoption of best management practices and land use, climate mitigation and adaptation, and perhaps most importantly, potential changes in the control over farm-level decision making. The coming advances in automation are set to remake the agricultural sector—but a proportional increase in welfare for participants throughout the sector is far from assured.

exist beyond Panel Models in Agricultural Economics**
Alan Ker, Michigan State University

There is certainly some recency bias on my part in the title in that I could easily supplant “panel models” with “randomized control trials”, “artificial intelligence”, or a few decades ago “nonparametrics”. In the past few months, I heard the statement that “artificial intelligence will kill econometrics” and have been asked by an Editor “why did I not use fixed effects” even though no panel model was estimated. Similarly, a few decades ago I heard arguments that the “space of models is dense and so the probability of choosing the correct specification is necessarily zero so one has to use nonparametric rather than parametric methods.” I investigate why this myopic behaviour is and always has been too pervasive, why only through the lens of history do we see various econometric approaches as complementary rather than competing, and why this will unfortunately continue into the future.

Nous visiterons la ferme North Arm en prenant le temps de savourer des boîtes à lunch et une visite guidée autonome avant de retourner à l'hôtel à 13h00.

Kathryn Harrison, University of British Columbia



Kathryn Harrison is a Professor of Political Science at the University of British Columbia. She received Bachelor's and Master's degrees in Chemical Engineering before completing her PhD in Political Science. Professor Harrison has worked in the oil industry and as a policy analyst for both Environment Canada and the United States Congress. She has served as Senior Associate Dean and Acting Dean in the UBC Faculty of Arts. Harrison has published widely on Canadian and US climate policy. She has advised governments from the local to international level, and is currently chair of the Expert Advisory Panel on climate mitigation of the Canadian Climate Institute and a member of the British Columbia Climate Solutions Council. Harrison is a frequent media commentator on climate policy, and tweets at @profkharrison.

Tristan Skolrud, University of Saskatchewan



Tristan Skolrud is an associate professor in the Department of Agricultural and Resource Economics at the University of Saskatchewan. His research focuses on the intersection between farm-level decision making and agri-environmental policy. Tristan has published in the leading journals of agricultural and resource economics, including the American Journal of Agricultural Economics, the Canadian Journal of Agricultural Economics, and the Journal of Agricultural and Resource Economics. Born and raised in Washington State, Tristan received a Ph.D. in economics from Washington State University in 2015 and an MA in economics from the University of Washington in 2011. At the University of Saskatchewan, Tristan teaches courses in agricultural finance and microeconomic theory.

Karina Schoengold, University of Nebraska-Lincoln



Karina Schoengold is a Professor in the Department of Agricultural Economics at the University of Nebraska-Lincoln. She is also a Faculty Fellow of the Daugherty Water for Food Global Institute at the University of Nebraska. She earned her B.S. in mathematics and economics from the University of Wisconsin-Madison and her M.S. and Ph.D. in Agricultural and Resource Economics from the University of California-Berkeley. She teaches undergraduate and graduate courses in natural resource and environmental economics. Dr. Schoengold's research interests are in the fields of environmental and natural resource economics, water resource economics, technology adoption, and ecosystem service valuation and has been published in both disciplinary and interdisciplinary journals, as well as book chapters, Extension publications, and newsletters. She has received funding for her research from sources such as USGS, USDA-NIFA, NSF, and local stakeholder groups.

Alan Ker, Michigan State University



After obtaining his joint Ph.D. in Economics and Statistics at North Carolina State University (09-92 to 03-96), Alan worked as a professor (and subsequently Head from 2002-07 in the Department of Agricultural and Resource Economics at the University of Arizona. In April 2009, Alan moved to Canada where he joined the Department of Food, Agricultural and Resource Economics in his new position as Chair and Professor. In September 2014, Alan concluded his 5-year term and became Director of the Institute for the Advanced Study of Food and Agricultural Policy. Alan served as the 2016-17 President of the Canadian Agricultural Economics Society and sits on

the editorial boards of the Canadian Journal of Agricultural Economics and the European Review of Agricultural Economics. In 2019, he became the OAC Research Chair in Agricultural Risk and Policy. Also in 2019, he became the Managing Editor of the Canadian Journal of Agricultural Economics. In 2021, Alan was named Fellow of the Canadian Agricultural Economics Society. Alan joined the Department of Agricultural, Food, and Resource Economics at Michigan State University where he holds the Elton R. Smith Endowed Chair in Food and Agricultural Policy.
